## Personal data protection:

1. Your personal data is administered by Masterchem Logoplaste spółka z ograniczoną odpowiedzialnością, ul. Przylep-Solidarności 86 D, 66-015 Zielona Góra, hereinafter referred to as the "Supplier".
2. Your personal data shall be processed by the Supplier for the purpose of sending e-invoices and keeping records. The legal basis for processing your personal data for the above purposes is Article 6 (1) 1 (F) GDPR. The legitimate interest of the Supplier consists of facilitating communication with the Supplier and effective forwarding of information regarding payments. Giving your data is not obligatory but it is necessary to achieve the above-mentioned objectives.
3. The Supplier will transfer your personal data to other entities authorized to process personal data on behalf of and for the Supplier. Furthermore, the Supplier will make your personal data available to other entities, if required to do so by the law. Your data will not be forwarded to third countries and international organizations.
4. The data shall be stored until the objective for which they have been obtained is achieved.
5. You shall be entitled to access your data and, subject to the provisions of the law: rectify, erase, limit processing of your data, transfer the data, file an objection and withdraw your consent at any time. Withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.
6. You shall be entitled to lodge a complaint to the President of the Personal Data Protection Office.
7. Your personal data shall not be processed by automated means and shall not be subject to profiling.
